Lunch: Children that enroll past 12:30 p.m. are required to bring their lunch each day.

Deposit: There will be a \$50.00 non-refundable application fee for all registering families. The deposit is equal to May tuition and will be applied towards May of 2011. The deposit is only refundable as long as a 30 day notice is provided. Space is reserved on a first come basis. September tuition plus your materials fee will be billed on the first day of school.

Late Tuition: \$15.00 late fee will be added to your amount due for payments received after the posted deadlines.
