Summer Session is for children 3-6 years old.

Lunch: Children participating in the summer after care program are required to bring their lunch each day.

Deposit: Due April 1st, 2010. The deposit is only refundable as long as a 30-day notice is provided. Space is reserved on a first come basis. The deposit is **\$100** per session. You will be billed for the remainder of the tuition and materials fees at the beginning of each session.

Late Tuition Fees: \$15 late fee will be added to your amount due for payments received after the posted deadlines.

Parent Co-op Volunteer Requirements: Please review the **La Casita Handbook for the parent volunteer requirements**. As a co-op, La Casita depends on a commitment from each family to keep our preschool clean, safe, and enhance our children's development through service and volunteerism.

At least two participation days per each summer session.

**Materials Fee and Tuition are listed for each session. Session I dates are 6/7/10 – 7/2/10.
 Session II dates are 7/5/10 – 7/30/10. Session III dates are 8/2/10-8/27/10.**
